- ⊕ * Additional fees must be paid for in full at the time of the activity or by arrangement with the College. Some activities may be paid by instalments due to the large nature of their cost. All items will be available for payment via My Student Account. The above are examples of the types of additional charges and is not an exhaustive list.

What do the fees & levies cover?

Tuition Fees	These fees are calculated based on the recommendations of Brisbane Catholic Education and the College Board. Tuition fees cover the recurrent costs within the College, examples include salary and wages, council rates, water, gas, electricity, phones, College technology infrastructure requirements.
Senior Levy	Senior Levy is a levy per senior student for Years 10-12 to assist with the requirements of external assessment in the senior years. This levy also includes the Student cost of Senior events in Years 11 and 12 eg: Semi Formal, Formal and Graduation
Resource & Activity Levy	Mt Maria College provides one levy combining subject levies, school camps, in-school sports programs (SECA), academic competitions, miscellaneous tuition activities and consumables, guest speakers & local excursions. The Textbook and Laptop Hire are included in this amount. Attendance at Excursions, Camps and Retreats is an expectation that supports curriculum and personal development and no refunds are available for non-attendance.
Capital Levy	This is a compulsory levy charged per family. It is used to help meet the maintenance and refurbishment program of current facilities together with contribution to the cost of current and future commitments of building projects. This levy is <u>NOT</u> tax deductible.
P&F Levy	The P&F levy is a per-family levy collected on behalf of the Mt Maria College P&F. The funds are used to complete projects supporting student amenities, and curricular and co-curricular activities at the discretion of the P&F Committee and members. Every parent is automatically a member of the MCM P&F and all parents are invited to the monthly meetings.

Additional fee information

<p>Other Expenses</p>	<p>Other expenses include such things as Immersions, Instrumental Music Program and related competitions, special personal development programs, representative sporting carnivals and recreational trips are not included in the College fees. These can be paid via the College Payment Portal. A sample of other expenses are listed on page 4.</p>
<p>Issuing of Accounts</p>	<p>Fees and levies are charged once per year at the beginning of the year and are to be paid by the due date in term one unless approved payment arrangement is in place where all College Fees and Levies are required to be finalised by the end of the academic year. Updated statements will be sent at the beginning of each term. All families are asked to pay accounts by direct debit and may choose instalments that suit the family eg: full year, by term, monthly, fortnightly or weekly.</p>
<p>Methods of payment</p>	<p>Direct Debit via College approved application is the preferred method of payment for fees. Access and Forms can be arranged with College Finance.</p> <p>Payments for other expenses may be by made via the College Payment Portal My Student Account. Instructions can be found on the Parent Portal and website. Please contact the Finance office for other payment alternatives.</p>
<p>Multiple family enrolments</p>	<p>Families with more than one student at the College receive a discount on tuition fees. However, all other levies apply in full. P&F levies and capital levies are charged per family and not per student.</p>
<p>Overdue accounts</p>	<p>An overdue account is an account that remains unpaid after the due date or falls behind an approved direct debit schedule. Should accounts continue to remain outstanding, parents/carer should contact the Business Manager to discuss the outstanding fees.</p> <p>Unfortunately, the College has had to call on the services of a Debt Collector to approach parents who refuse to communicate in these matters.</p> <p>In the event the College incurs costs and expenses as a result of pursuing outstanding fees from parents/guardians, the parent/guardians will be responsible for the payment incurred costs and expenses. Please refer to the Mt Maria College Fee Policy for further information.</p>
<p>Concessions</p>	<p>The College invites you to contact the Finance team if you are having difficulty paying your fees by the due date. Concessions are considered at the commencement of each year or when hardship within the family occurs.</p>
<p>Discounts</p> <p>Upfront Payment</p> <p>Sibling Discounts</p>	<p>A 5% discount on the annual tuition fee (excluding all levies and Building Fund Contribution) is offered if full fees and levies for the year are paid within 14 days after the issue of Term 1 Annual Fee Statement.</p> <p>As per schedule, or 5% discount on Tuition fee for siblings at associate BCE North West Collective Schools where no other sibling or other discounts in place.</p>
<p>Voluntary Building Fund Contribution</p>	<p>Families can contribute to our building program by making a payment to the voluntary Building Fund. The amount of \$150 is printed on the fee statements as a suggested amount. Any contributions made are tax deductible. A tax deductible receipt will be sent at the conclusion of the current financial year.</p>
